Inactive voter status does not disqualify a candidate (1-2-605(3), CRS). To meet Fair Campaign Practices Act requirements, the DEO must file copies of the Self Nomination forms or a list of the names of all valid candidates with the county clerk and recorder no later than 60 days before the election (SOS CPF Rule 8).
